# AGREEMENT CONDITIONS

**ARTICLE 1:** Companies signing the application form to participate in the exhibition will be referred to as (EXHIBITOR) in the rest of the contract, whereas AVRASYA FUARCILIK LTD. STI. will be referred to as (EURASIA TRADE FAIRS). For the document to be effective, it is necessary for the parties to accept all conditions of participating as they are.

**ARTICLE 2:** In order to be registered for the exhibition, the exhibitor must forward the relevant payment together with the signed application form to Eurasia Trade Fairs. Eurasia Trade Fairs will then send an official confirmation of the stand allocation.

**ARTICLE 3:** The exhibitors liability begins as of the signature of the application form, any change in the decision of partaking in the exhibition or the fair does not release the client from his liabilities.

**ARTICLE 4:** Eurasia Trade Fairs shall make the exhibition area ready by dividing into stands, securing electrical equipment and providing one spot of 100Watts for each 3square metres. The stand to be rendered to the exhibitor, the number dimensions, price and terms of payment shall be indicated in the application form.

**ARTICLE 5:** The exhibitor is obliged to secure Eurasia Trade Fairs' appropriation regarding the project of special decoration. Eurasia Trade Fairs has the authority to control the project and make necessary amendments for securing its conformity.

**ARTICLE 6:** Eurasia Trade Fairs reserves the right to amend the plans of exhibit areas and move the position of stands if required by the venue owners or for any other valid reason.

**ARTICLE 7:** One square meter shall be taken as a unit as the calculation of the exhibition rental. The fee comprises the following services which will be executed by Eurasia Trade Fairs;

**I-**The promotion of the exhibition through different media, its introduction to the sector and the public.

**II-**The preparation and equipment of the exhibition area and of the stands, provision of electricity, spotlights and fascia for package booths.

**III-**The securing of services pertaining to the Information Office.

**IV-**The securing of safety within the building, the execution of the cleaning services.(the exhibitor is responsible for the cleaning of rented stand space)

**V-**The printing of the exhibition catalogue and its distribution to related parties.

**VI-**The insurance of the exhibition related people against risk of fire, malicious actions, explosions, and internal inundations throughout the exhibiton period.(exhibitors should insure their own products)

**ARTICLE 8:** Services those are not included in the stand rental fee yet provided upon the request of the exhibitor in return for an extra fee are as follows;

**A-** Telephone connections

**B-** Catering services

**C-** Advertising in the exhibiton catalogue

**D-** Additional stand fixtures and furniture

**ARTICLE 9:** The exhibitor should do the interior decoration of the stand himself and meet its expenses. Having an official person to give technical and commercial information from the day of the opening of the exhibition until its termination is also included among the clients responsibilities.

**ARTICLE 10:** The exhibition will be open between 10:00 – 19:00 between 05 – 07 June 2014. During these times, stands and exhibits must not be covered up and personnel must be in attendance.. Opening hours may be subject to change.

**ARTICLE 11:** Exhibitors will be permitted to remove goods from the exhibition areas from 19:00, 07 June till 14:00, 8 June 2014. Goods and equipment not vacated within this period may be carried outside the boundaries of the exhibition area by Eurasia Trade Fairs personnel without any advance warning. The responsibility of probable damages and meeting kinds of expenses is incumbent of the exhibitor.

**ARTICLE 12:** The whole or part of the exhibition organization undertaken by Eurasia Trade Fairs may be rendered impossible by reasons which can be defined as force majeure (situations beyond the control of the organizer such as actions of the Government and Official bodies, war, strikes, uprising quarantine, epidemics, agitation, natural disasters, national or sectoral crisis). Upon occurrence of one of the aforementioned causes Eurasia Trade Fairs will be exempt of all liabilities.

**ARTICLE 13:** The exhibitor signing the application is bound to comply to the latter with the conditions of participation and to the exhibition calender specified.

**ARTICLE 14:** Once the contract has been concluded, it is not possible for the exhibitor to rescind the contract or reduce the stand space allocated. If the organizer is able to relet the stand, the exhibitor shall be liable for 65% of the total stand rental as compensations up until 5th March 2014. After that date, the exhibitor will be liable for 100% of the total amount.

**ARTICLE 15:** Eurasia Trade Fairs will issue an invoice for the total amount of the participation cost once the fair services are delivered.

**ARTICLE 16: LATE PAYMENT:** If for any reason payments are delayed and not made according to the conditions agreed upon in the application form then the total amount due will be considered to be Late Payment and without prior notice the following penalties will apply;

**A-**From the date that late payment is ascertained, the monies owed will be from that moment calculated in Turkish Liras and Eurasia Trade Fairs will have the right to demand payment in any currency of their choice.

**B-**From the date that late payment is ascertained until the date full payment has been made, interest will apply to the outstanding amount at 10% per month for Turkish Lira debts and at 3% for debts in any major traded foreign currency

**ARTICLE 17: SCOPE OF THE AGREEMENT:** This agreement represents a mutual and binding contract between the two parties and supersedes any previous verbal or written understandings made between the parties. In the event of amendments to this agreement, they will be written into the document and signed by authorised representatives of each party.

**ARTICLE 18: PARTITION OF THE AGREEMENT:** If for any reason a court of law rules that part or all of any items of this agreement is not legally binding, it will not effect the legality of the remaining items.

**ARTICLE 19: EVIDENCE CONDITION:** In the event of a disagreement between the parties and if there is any contradiction in documentary evidence, the records and documents of Eurasia Trade Fairs will be legally binding.

**ARTICLE 20: LEGAL JURISDICTION:** In the event of a disagreement between the two parties of this contract, Turkish law and the Istanbul courts will be the higher authority and their decisions binding..

**ARTICLE 21:** The agreement conditions constitutes part of the application form, the contract is binding when the application form is signed

**ARTICLE 22:** This agreement is made up of 22 items
